BOARD OF DIRECTORS CALL FOR **NOMINATIONS**

PRESIDENT

The President shall preside at all meetings of the Board of Directors and have general supervision of affairs of the Corporation and any additional duties prescribed by the Board. The President will perform all functions ordinarily performed by a corporate president.

VICE PRESIDENT

The Vice President will perform duties as assigned by the President and serve in place of the President when they are absent.

TREASURER

The Treasurer will have general control of C&G's funds, supervise the collection and disbursement of said funds, and be responsible for C&G's funds and securities. In addition, the Treasurer will chair the Finance Committee and perform all duties generally performed by a corporate treasurer.

SECRETARY

The Secretary shall attend and keep minutes of all meetings of the Board and members. The Secretary is responsible for notifying Board and members of meetings and shall perform all duties ordinarily performed by a corporate secretary. In addition, the Secretary will chair the Communications Committee

ALUMNI AND STUDENT ENGAGEMENT COORDINATOR

The Coordinator must be an Alumnus who has graduated within the past 10 years and will be responsible for identifying opportunities for enhanced engagement within and between C&G delegations. In addition, they will chair the Alumni and Student Programming Committee.

HISTORIAN

The Historian will be responsible for improving and preserving existing institutional documentation and knowledge, and compiling archival information. They will also oversee the documentation of current stories and narratives to preserve and record events in C&G (i.e. notable changes in governance, organizational structure, major decisions or achievements for the organization). In addition, the Historian will oversee the development of engaging projects and programs to memorialize the history of the organization. The Historian will also serve as a member of the Communications Committee.
